The **Overall Assistance for Startup Immigration System (OASIS)** is a program operated by **Global Start-up Immigration Centers** jointly designated by the **Ministry of Justice** and the **Ministry of SMEs and Startups of the Republic of Korea**, with the aim of promoting domestic startup activities by foreign entrepreneurs with outstanding technological capabilities.

The **Advanced Intellectual Property Course (OASIS-2)** is organized by the **Global Startup Immigration Center** operated by **Korea Management Association Consultants Inc. (KMAC)**.

A. Program Overview

1. Program:

Advanced Intellectual Property Course (OASIS-2), 1st Cohort

(This program will be conducted entirely in English.)

2. Objective:

To provide advanced coursework required for intellectual property acquisition and in-depth education on essential knowledge on residency and startup ecosystem in Korea.

3. Eligibility:

Graduates of the OASIS-1 program who are legally residing in Korea and intend to establish a technology-based startup in Korea.

4. Application Period:

June 01 (Mon), 2026 – June 14 (Sun), 2026, until 24:00 (KST)

5. Application Method:

Submission of required documents, including the application form, sworn statement form, proofs of immigration/residency status and OASIS-1 Completion Certification via email.

6. Training Schedule:

June 26 (Fri) – June 28 (Sun), 2026

(Total of 20 hours over three days)

7. Completion Requirements:

Participants who attend at least 80% of the total program will be granted a certificate of completion.

8. Venue:

Global Startup Immigration Center

(3rd Floor, Goryeo Building, 76 Keunumul-ro, Mapo-gu, Seoul)

9. Benefits of Participation:

- Accumulation of OASIS points required for obtaining startup immigration visas (Technology Startup Visa D-8-4 and Startup Preparation Visa D-10-2)
- Eligibility to participate in the next stage of the program (OASIS-3)
- Completion of advanced training for technology-based startups in Korea
